PRESIDENTS MESSAGE NOVEMBER 2014

Dear Brothers and Sisters,

There hasn't been much news regarding any Provincial Bargaining issues. The Provincial Bargaining Team has another date with the government scheduled for November 18, 2014. We are still waiting for them to set out what are Local and what are Provincial bargaining issues before we can start bargaining locally. I will keep you informed as I hear of any updates.

It looks like we will be going forward with our Charter Challenge. As talked about previously, CUPE has started a Charter Challenge to the Supreme Court of Canada over the Ontario Government's handling of bargaining, and it's changing of the law under Bill 115 that has stripped away our Collective Bargaining rights. If successful, we will be looking to have our sick days and other provisions that were stripped out of our Collective Agreement put back in place. If we were to be successful in this Charter Challenge, it most likely would be appealed by the Ontario Government and may go on for the next few years, but we do stand a reasonable chance of winning. I will keep you posted as to how it unfolds, but as of now, it is not being heard until April 2015.

On November 12 and 13, we were in front of the OLRB (Ontario Labour Relations Board) to have a ruling made regarding our statutory freeze and layoffs from our last round of Provincial Bargaining.

Since this is our last newsletter before the Christmas break, I would like to take this opportunity to wish everyone a very safe and happy holiday season!!

Dear Sister and Brothers:

It's hard to believe this is our last newsletter before the Christmas break. Time waits for no one.

Our Provincial Bargaining team has had their two initial meetings with the Council of Trustee Association and the Government. Our team has made some progress but there are still issues between the parties. For example, the Government predetermined the location and dates of bargaining without consulting CUPE. They are providing single dates to bargain instead of consecutive dates, which is not cost effective or productive. We are looking for a commitment for consecutive dates to keep bargaining momentum going. Once these issues have been worked out, they will start to discuss what will be dealt with at the central table. As things progress we will continue to keep you updated.

On November 13, 2014, the Catholic Board will be challenging the redundancies at the Ontario Labour Relations Board. We will be dealing with preliminary issues. The employer's side more than likely will be bringing up issues of jurisdiction and that this issues should be arbitrated and not be before the OLRB. Again, we will keep you up dated as this process unfolds.

As always, if you sustain a workplace accident or injury please contact the CUPE office and one of our disability management team members will assist you.

Our next and final General Membership Meeting for 2014 will be Sunday November 23 at 7:00 pm.

Good afternoon

As we continue to implement our Employee Self Serve Portal we are pleased to advise that we will no longer be issuing a "paper" paystub for all employee groups. The exception to this is lunchroom supervisors, who will continue to receive a paper paystub into the foreseeable future. Below is a list of the effective pay date that you will not receive a paper paystub.

Staff can go to the Staff Portal and launch Employee Self Serve (ESS) either as a Quick Link or the button on the left side menu. Upon log on to ESS, click on Employee Services, click on Personal, click on Pay-Stub. You can view the current stub or can view history by changing the date in the upper right hand corner of the screen. You may optionally select to print a copy by clicking on the printer icon also in the top right corner on the screen. The url link below provides instructions on how to log onto Staff Portal and ESS

HEALTH AND SAFETY

EAs dealing with violent incidents

There is an increase of violent incidents reported this year. It is important that all violent incidents are reported to your admin and that the paperwork gets done. If you don't report it, it never happened. Refer to the EAs Go To Guide for health and safety for information regarding reporting and Personal Protective Equipment (PPE)...to find the guide go to the DDSB Staff portal - Business/technology - occupational health and safety tab - EA's go to guide for health and safety. You can also bring a copy or refer to it when discussing reporting/or requesting PPE with your principal. Also, fill out the CUPE violent incident (yellow) form on your own time and send it to the CUPE office, attention: Marion Moore. If you are hurt, scratched or bitten you need to fill out the SAIR (also known as Parklane) form with your principal.

Request a debriefing after dealing with the violent incident. Refer to 5127 - Procedure - Management Process For Risk-Of-Injury (Ri) Behaviours - located in the DDSB staff portal, policies and procedures - type in 5127. This procedure is available for all staff to read and it includes a checklist for debriefing. All EAs should take the time to review procedure 5127 and the EAs Go To Guide for Health and Safety and become familiar with them.

Custodial/Maintenance

Working at heights training to start November 14 the at old Donevan site. It will run from 7:30- 2:30 and is mandatory. 20 staff per session. All members should also remember to be inspecting their ladders before use and that anything over 3 meters(6 ft.) should have two people and always maintain that 3 point contact. If you have concerns around this due to having repair items and the tools required, then request a tool belt be purchased. With regards to roofs and access, the board is being very proactive with repairs and upgrades. If there are any issues then input a work order right away. Remember to stay at least 6 feet away from edges, a ball isn't that important.

Remember now that we are only to be removing soft metal type locks from lockers most commonly these are Dudley brand. Any other please issue work order so that they can be remove in a safer manner.

Lastly with the winter fast approaching I recommend that you take a walk around to notice uneven pavement and log it so that you can remember its location. Thus hopefully not to get hurt or injured removing snow. Also please remember your safe operation of snow blowers.



<u>Your Paystub:</u> The DDSB is going paperless. The plan for Con Ed is to discontinue mailing the paper stubs in early December. You can view your paystubs online in the Employee Self Serve (ESS) section of the staff portal. The online version provides more detailed information. Please remember to keep copies of your timesheets and to check that your pay matches your submission of hours.

Your T4s and T4As: Your T4 is available electronically in ESS but be aware that although this could be convenient for some, once you click the "I CONSENT" button, your T4s will be available online as your only method in the future. It will be your responsibility to print your T4 yourself. As a CON ED employee who may have numerous contracts in any year, if your contract is not valid when you need to print your T4 you may not have access to the staff portal therefore you may need to contact the Board directly.

<u>Sick Day Payout:</u> At our Labour Management meeting we were very eager to come to a full resolution in the matter of the outstanding sick days for our four remaining members.

We brought copies of the time sheets and the pay stubs to prove that in fact, the members had not been paid. On October 28th the board said they would take it back to payroll again to review.
